## **PSDS 3b Early Spend**





### **Early Spend**

- Offer to grant recipients to submit claims for cost of eligible works incurred between their grant start date and 31 March 2023.
- The grant start date will be the day you sign and return your grant offer letter to Salix.
- We are forecasting an underspend from PSDS Phase 3a projects for FY 22/23 and will this available to Phase 3b projects to start works early.
- If paid for works in FY 22/23, the grant value awarded will not change, but the amount available in FY 23/24 will reduce.
- Salix cannot guarantee the grant recipient will be able to claim for all eligible works up to 31 March 2023. Nevertheless, we do not expect PSDS Phase 3b claims to exceed the underspend available based on current indications.







### **Forecasting early spend**

- Early spend forecast value must be submitted in the first monthly monitoring report by Wednesday 15 March 2023.
- In support, a 3b early spend statement of expenditure must also be submitted.
- The early spend forecast should only include costs expected to be incurred before 1 April 2023.

### **Evidencing spend**

- All early spending must be for works that take place on or before **31 March 2023.**
- All invoices and any other supporting evidence must clearly show when the works were undertaken.
- Evidence dated after the 31 March 2023 will only be accepted if it states the works were completed by 31 March 2023.
- Location, technology, type of expense, dates of work
- e.g. 'Head office heat pump Contractor fees for 01/03/23 to 31/03/23'



### **Payment request**

- All payment requests for invoiced works are to be submitted to Salix by **Thursday 20 April 2023**.
- We will not be able to confirm the final underspend till early May 2023, once all current PSDS projects have received final payment.
- Should insufficient underspend be available to cover all the grant applicants' claims for works completed before 1 April 2023, all valid funding claims will be partially paid on a pro-rata basis.
- It will not be possible to resubmit claims for works completed in FY 22/23 (before 1 April 2023) for payment in FY 23/24.



### **Payment request documents**

- Schedule 5 Payment Request
  - Template found in your Grant Offer Letter detailing the claim value and bank details
  - Signed by Accountable Officer (can be done via DocuSign)
- Statement of Expenditure
  - Excel document to summarise the invoice evidence provided
  - Signed by Accountable Officer in PDF format (not a typed signature)
  - All fields must be completed
- Evidence (invoices)
  - Clearly states what work has been completed and when this took place
  - Includes your PSDS project reference and the site name(s)
- Please reach out to your Salix relationship manager for further guidance.
